HAZARDOUS SUBSTANCES ACT 15 OF 1973

GROUP IV HAZARDOUS SUBSTANCES: EXCLUSIONS AND EXEMPTIONS

Published under Government Notice R246 in Government Gazette 14596 of 26 February 1993.

- I, Barend Leendert Geldenhuys, Deputy Minister of National Health, acting on behalf and by direction of the Minister of National Health -
- (1) do hereby determine in terms of subsection (5) (a) of <u>section 3A</u> of the Hazardous Substances Act, 1973 (Act No. 15 of 1973), that the provisions of subsection (1) of that section shall not be applicable to any Group IV hazardous substance with a total activity of -
 - (a) 4 000 Bq or less; and
 - (b) more than 4 000 Bq but less than the maximum activity indicated in the Annexure hereto, where such Group IV hazardous substance forms part of a device indicated opposite to such maximum activity, except in the case where such device is manufactured in or imported into the Republic; and
- (2) hereby in terms of subsection (5) (b) of <u>section 3A</u> of the said Act exempt from the provisions of subsection (1) of that section any person or organisation and any person in the employ of such person or organisation, except a holder of an authority referred to in subsection (1) of that section, who transports a Group IV hazardous substance by rail, road or air for or on behalf of such holder.
- (3) This notice shall come into operation on 1 March 1993.
